Brief Product Information:

EROXIB-90, manufactured by **AstraEureka** Pharmaceutical, contains Etoricoxib 90 mg, a selective COX-2 inhibitor used for pain and inflammation relief. As a manufacturer of this composition, AstraEureka ensures high-quality standards in formulation and packaging. EROXIB-90 is indicated in osteoarthritis, rheumatoid arthritis, ankylosing spondylitis, gout, and dental or post-operative pain. The tablet acts by selectively blocking COX-2 enzyme, minimizing gastrointestinal side effects typical of non-selective NSAIDs. Recommended dosage is 90 mg once daily, as prescribed. Use with caution in cardiovascular, renal, or hepatic conditions. Common side effects include nausea, dizziness, and elevated blood pressure. Contraindicated in pregnancy, severe heart conditions, and active ulcers.

Safety Information:

2. Avoid alcohol consumption
3. Use with caution in elderly and patients with history of cardiovascular disorders
4. Not suitable for children below 16 years
5. Do not exceed recommended dose

Mechanism of Action:

- Etoricoxib is a selective cyclooxygenase-2 (COX-2) inhibitor
- Inhibits the enzyme COX-2 involved in prostaglandin synthesis
- Reduces pain and inflammation without significantly affecting COX-1
- Less gastrointestinal irritation compared to traditional NSAIDs

Contraindications:

1. Hypersensitivity to Etoricoxib or any component of the formulation
2. Active peptic ulcer or gastrointestinal bleeding
3. Severe hepatic or renal impairment
4. Uncontrolled hypertension
5. Patients with ischemic heart disease, cerebrovascular disease, or peripheral arterial disease
6. Pregnancy and lactation

Side Effects:

1. Headache
2. Dizziness
3. Hypertension
4. Indigestion or nausea

5. Edema
6. Elevated liver enzymes
7. Skin rash
8. Fatigue

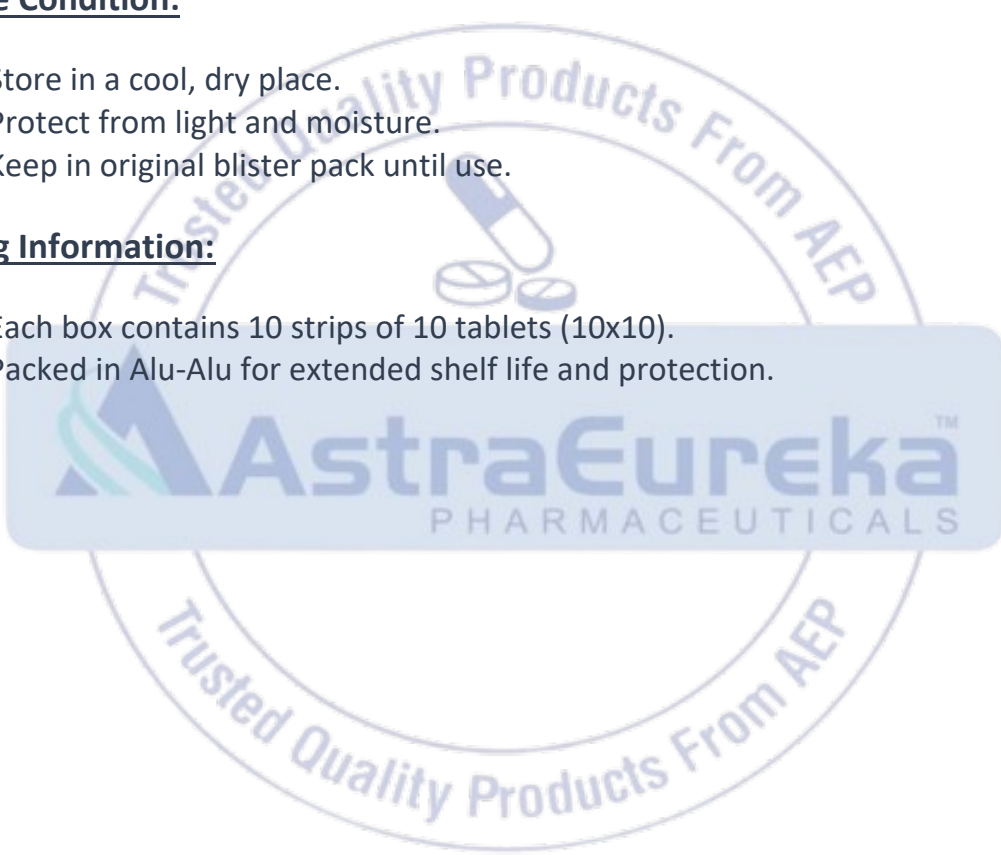
