This unique formulation helps increase appetite, supports liver detoxification, and improves nutrient absorption, making it ideal for underweight individuals, children with poor appetite, or patients recovering from illness. It also aids in managing hepatic disorders and conditions with poor protein metabolism. Recommended dosage is based on age and medical advice. The syrup is palatable and well tolerated. Not recommended for children under 2 years or during pregnancy without medical supervision. Supplied in a 200 ml PET bottle, it is easy to dose and store. Shake well before use.

Composition:

Each 5 ml contains:

- Cyproheptadine Hydrochloride IP
Equivalent to Cyproheptadine Hydrochloride Anhydrous.....2 mg
- Tricholine Citrate.....275 mg
- Flavoured Sorbitol Base.....q.s.

Key Ingredients:

2. Avoid in children under 2 years of age
3. Use with caution in elderly patients and those with glaucoma
4. Do not consume alcohol during treatment
5. Safe use during pregnancy and lactation only under medical supervision
6. Do not drive or operate machinery if drowsy

Mechanism of Action:

- **Cyproheptadine** acts as a serotonin and histamine antagonist. It blocks H1 receptors and serotonin (5-HT) receptors in the hypothalamus, stimulating appetite and reducing allergic symptoms.
 - **Tricholine Citrate** promotes hepatic uptake and metabolism of fats and helps in the synthesis of phospholipids. It assists in detoxifying the liver and preventing fat accumulation.
- Together, they enhance appetite, improve digestion, and support liver health.

Contraindications:

1. Hypersensitivity to any component
2. Narrow-angle glaucoma
3. Urinary retention

4. Severe liver impairment
5. Pregnancy and lactation (without medical advice)

Side Effects:

1. Drowsiness
2. Dry mouth
3. Mild dizziness
4. Constipation
