Contraindications:

- 1. Hypersensitivity to Sucralfate, Oxetacaine, or any excipients.
- 2. Severe renal failure (due to risk of aluminum accumulation).
- 3. Intestinal obstruction or chronic constipation.
- 4. Use in children without physician supervision.
- 5. Concurrent use with other aluminum-containing medications.
